

## TERMS AND CONDITIONS FOR “JURASSIC WOIRLD FALLEN KINGDOM PRIVATE SCREENINGS GIVEAWAY 2018

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this ‘**Jurassic World Fallen Kingdom Private Screenig Giveaway (“Promotion”)** is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on NSW local time.
2. The “**Promoter**” is Jones Lang Lasalle (NSW) Pty Limited (ABN 37 002 851 925) of Level 8, World Square, 644 George Street, Sydney NSW 2000, telephone: 02 8275 6777 (“JLL”).

### ELIGIBILITY

2. Subject to condition 3, this Promotion is only open to Australian residents aged 18 years or over.
3. ### JUDGING DETAILS
