

## TERMS AND CONDITIONS FOR “WORLD SQUARE Christmas Bauble Selfie Campaign 2018” PROMOTION 2018

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “World Square Christmas Bauble Selfie Campaign 2018” Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on NSW local time.
2. The **“Promoter”** is Jones Lang Lasalle (NSW) Pty Limited (ABN 37 002 851 925) of **[Level 8, 644 George Street, Sydney NSW 2000]**, telephone: **[02 8275 6777]** (“JLL”).

### ELIGIBILITY

2. Subject to condition 4, this Promotion is only open to Australian residents aged 16 years or over.
