

TERMS AND CONDITIONS FOR “WORLD SQUARE SOUND SHINE” PROMOTION 2019

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “**SOUND SHINE**” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on NSW local time.
2. The “**Promoter**” is Jones Lang Lasalle (NSW) Pty Limited (ABN 37 002 851 925) of Level 8, 644 George Street, Sydney NSW 2000, telephone: 02 8275 6777 (“**JLL**”).

ELIGIBILITY

2. Subject to condition 4, this Promotion is only open to Australian residents aged **16 years or over**.
3.
